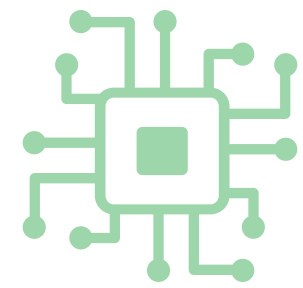

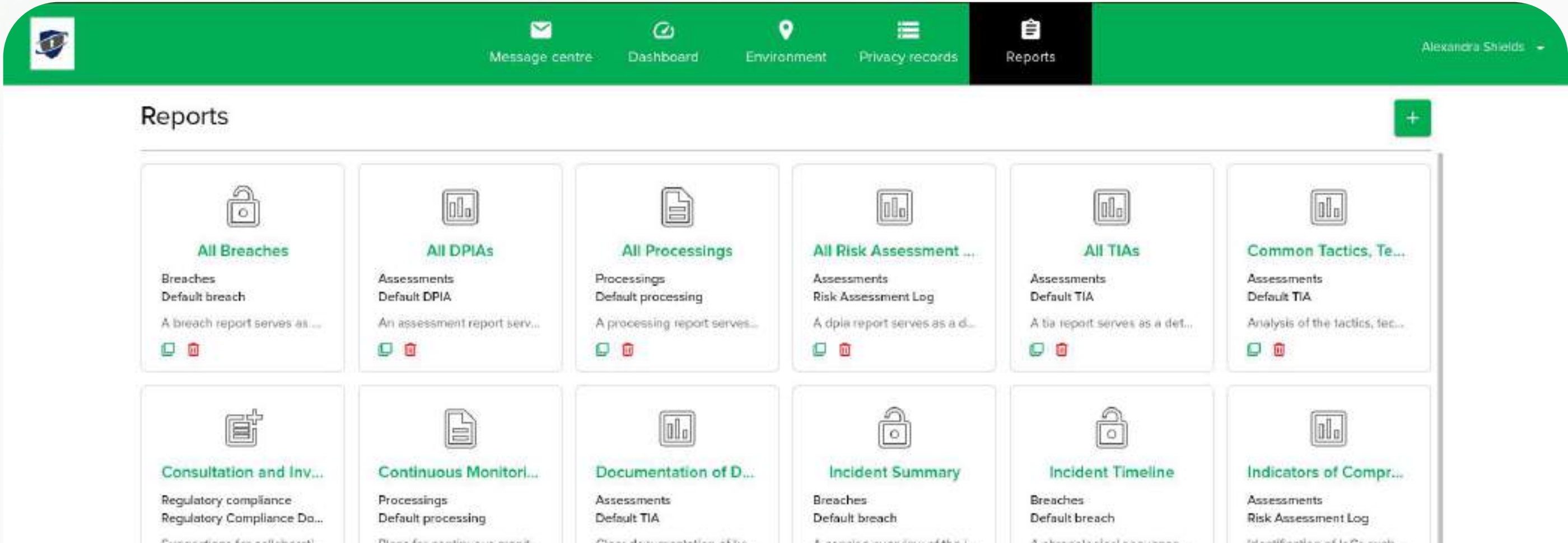

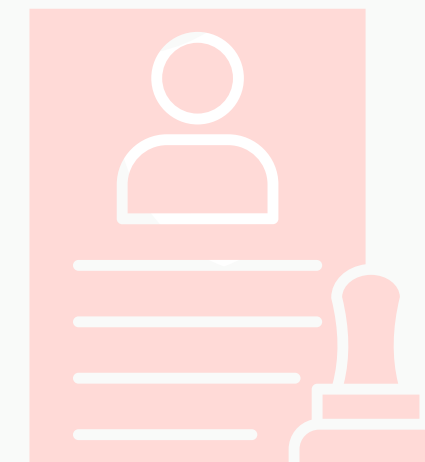

Multi-tenancy

Back End

- **Multi-tenancy architecture:** Implements a multi-tenancy architecture with individual databases for each tenant, ensuring strong data security and confidentiality through effective isolation measures.
- **Integration with the application's API :** Facilitates secure third-party access for streamlined integration with the application's API.
- **Microservices backend (Scala AKKA) :** Utilizes a microservices architecture built on Scala AKKA, ensuring scalability, fault tolerance, and efficient communication through RabbitMQ.
- **Version history and change log:** Features a robust "Change Log" function allowing users to compare different versions of privacy records, creating a comprehensive audit trail.

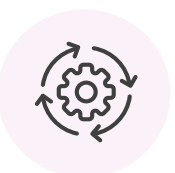
